Terms & Conditions:

1. Eligibility for Funding (Company Sponsored)

- Companies must be registered or incorporated in Singapore to qualify for SkillsFuture Singapore (SSG) funding.
- Employees must be Singapore Citizens or Permanent Residents to be eligible for the subsidies under SkillsFuture Singapore.
- Employees must meet the minimum attendance requirements and complete all assessments for the course to qualify for funding.
- In the event the employee falls to meet attendance or assessment requirements, the company will be responsible for the full course fees.

2. Absentee Payroll Funding

• Companies are eligible to apply for Absentee Payroll (AP) funding to compensate for employees' time spent on training.

3. Eligibility for Funding (Individuals)

- Individuals must be Singapore Citizens or Permanent Residents to be eligible for SkillsFuture Singapore (SSG) subsidies.
- Individuals must be at least 21 years of age at the time of course enrollment.
- Participants must meet the minimum attendance requirements and successfully complete all assessments to qualify for the subsidies.

4. Use of SkillsFuture Credit

- Eligible individuals can use their SkillsFuture Credit to offset course fees.
- SkillsFuture Credit claims must be submitted via the SkillsFuture Credit portal before the course starts.

5. Assessment

- This course includes two assessments, each I hour long, conducted each day.
- Learners must participate in and pass these assessments to fulfill course requirements.
